Set Up, Participation & Departure

1. Set up begins at 9am on Saturday, May 10th. Vendors are required to be ready by 10:45am.
2. Vendor is to make sure that table is draped properly and that the table drape goes to the floor. Nothing visible under the table.
3. Vendor has an 8 foot space available. Each Vendor must provide their own table and chairs. Everything must be contained within this space: you, your sitter, your signage, your Items, etc.
4. Each vendor's space will be labeled within the museum on a map to be provided by Samantha.
5. You may park at the museum entrance to unload your items for set up. Please move your car to Academy Place once you are done.
6. Vendor's unit should be self-contained and all items attached to your display. Do not attach anything to the walls or displays within the museum.
7. Vendors who collect sales tax are responsible for their own collection and payment of taxes. Fulton County Historical Society and Into Wishin' are not responsible.
8. No early departures or early breaking down of your booth. Please make sure that you do not break down until 4pm.
9. There will be **NO REFUNDS FOR ANY REASON OF YOUR EVENT FEE.**
10. Event fee is \$75. Your space is not guaranteed until you have paid your event fee.
11. Please remove ALL garbage and personal belongings when you pack up.
12. Vendor is responsible for lost, stolen or broken items.
13. Vendors must be packed and ready to leave the Fulton County Historical Society by 6pm.
